Free Tax Services

HCC's clinic is scheduled to remain open every Wednesday from February 9th through April 13th (excepting March 16th). Clients will be seen by appointment only.

t is time to report to Uncle Sam once more and HCC is here to help you. Thanks to Community Tax Aid, members of our neighborhood can benefit from free tax preparation.

To qualify, an individual's income may not exceed \$25,000 annually. The household income of married individuals and those with one or more people whom they support must be equal to, or less than, \$50,000.

Over the last several years, Housing Conservation Coordinators and Community Tax Aid served hundreds of people on the West Side. We now affirm our commitment to providing these free services for the 2011 tax season.

In this economic downturn, we recognize that many of our families have been strongly affected and we are eager to help however we can.

Due to the high volume of clients, our office will not begin scheduling appointments until the first week of February.

For families to utilize the services, each family member must schedule an individual appointment.

All registered clients must bring with them copies of their previous year's tax returns and a current W2 form if they have worked, as well as any 1099 forms they have received. Those who have not previously

used our service should also bring identification, including a social security card.

Because of the number of individuals interested in benefitting from the program, any client that does not attend his/her scheduled appointment will no longer be eligible to participate.

The tax clinic (which is not a legal assistance service) will remain open from 6:00pm to 8:00pm at 777 Tenth Avenue, New York, 10019.

Keep warm in cold weather



By law, your landlord is required to keep the temperature inside their building at least 55 degrees between 10:00 pm and 6:00 am when temperatures outside fall below 40.

HCC's Weatherization Assistance Program Educates our Community on Energy Efficiency

hile a traditional light bulb is a cheap way to light a room, in the long run it can be quite costly. Unfortunately, many consumers fail to realize that an incandescent bulb will result in higher electric bills. Even those aware of the problems associated with inexpensive bulbs hesitate to take the extra time and effort to change their ways and save money.

That is where HCC's Weatherization Assistance Program steps in. Here at HCC we take great care in helping tenants understand how they can transform their homes into energy efficient environments. The presentations we continue to make to tenants and building owners affirms our 2011 goal of teaching our local community members the various ways in which they can save money.

iust ten 60-watt incandescent bulbs with 13-watt Energy Star compact fluorescent bulbs (CFLs), an apartment will save an average of \$420 dollars annually. Aside from the financial savings, switching to CFL bulbs is an easy way to help prevent greenhouse gas emissions in our community.

Recycling Your CFLs

Local tenants are encouraged to take advantage of HCC's recycling program for their CFLs. Individuals may drop off used CFL bulbs at our agency located at 777 Tenth Avenue. Last year over two hundred bulbs were disposed of as local tenants played a role in aiding our planet.

Supplemental Rent Increases Suspended for Some Tenants

For leases going into effect between October 2008 and September 2010, the Rent Guidelines Board imposed supplemental rent increases for tenants with rents below \$1,000 who have lived in their apartments for at least six years.

For leases going into effect between September 2008 Know and October 2009, the increases for these tenants were Your set at \$45 for one-year leases and \$85 for two-year Rights! leases. For leases going into effect between October 2009 and September 2010 these tenants faced increases of \$30 (one-year lease) or \$60 (two-year leases.)

> In January the Supreme Court found that the minimum increases imposed on long terms tenants with low rents were invalid. This decision was upheld by the intermediate appellate courts and is currently pending before the Court of Appeals, which is expected to issue a decision in early 2011.

In light of the courts' invalidation of the supplemental rent increases, the Rent Guidelines Board has suspended these increases.

If you have been paying, or are being charged, these increases pursuant to leases issued between October 2008 and September 2010, you may have grounds to request a corrected lease from your landlord as well as a refund for overpayments. If you have questions about your lease, please visit HCC for further information during intake hours on Mondays from 4:00pm to 6:30pm and Thursdays from 10:00 AM to 12:30 PM. To be eligible for our services you must live between 34th and 72nd Street, from Eighth to Twelve Avenues and meet our income guidelines (See page 4). If you're not eligible for intake, HCC offers a free legal clinic every Monday night (except on holidays) from at 7:00 pm - 9:00 pm. Visitors must call the front desk to reserve a spot. ■



HCC Assists our Community in Consolidating Credit

While the average credit card debt in the U.S. household remains 15,700 dollars and the 60day delinquency rate continues to increase and hurt local families, Housing Conservation Coordinators has committed itself to assist. Our goal is not only to educate our community in their consumer rights, but also to aid in the consolidation of their debt.

Every debtor's case will receive an all-inclusive a thorough evaluation, as well as assistance in obtaining a free credit report. Depending on the individual case, HCC Consumer Debt Specialist Monica Morante will negotiate with the collection agencies on behalf of the qualifying client. Ms. Morante is also available to help debtors develop the skills necessary to develop better financial planning. "We are not only focused on the short term in solving their problems... [We] also put more emphasis on helping our clients understand how to create a realistic monthly spending plan so they can build a strong and secure future", says Morante.

No More Debt!

Below are tips to manage your personal spending under control. These tips will no doubt strengthen your 2011 New Year's Resolution!

- Create a monthly budget.
- Write down your daily. spending and identify unnecessary spending at the end of the month to avoid further overspending.
- Don't spend money you don't currently have.
- Try to pay your credit card bill in full, or as much as possible, to avoid monthly interest (APR).
- Take advantage of coupons, and sales at retail stores.
- Limit the amount of credit.

those living between 34th and 72nd Streets, from Eighth to Twelfth Avenues. To qualify, individual income may not exceed \$38,000 annually. A household income of a family of two must be equal to, or less than, \$41,500; the upper income limit for a family of four is \$47,500. Call us at 212-541-5996.

Succession Rights for Remaining Family Members in Rent-Regulated Apartments

For family or family-equivalent members to "inherit" the right to live in their apartment after the tenant of record has vacated, they must demonstrate that they lived with

the tenant for at least two years (or one year if the remaining occupant is a senior citizen or disabled).

If you are a husband, wife, child, stepchild, parent, stepparent, sister, brother, step sister, step brother, grandparent, grand-

child, father in law, mother in law, son in law, or daughter in law and can demonstrate that you lived with the tenant of record for the required time period, you can succeed to the tenancy and get a lease in your name (or become the registered tenant if the apartment is rent-controlled).

If you are a "non-traditional" family member, you must demonstrate that you were emotionally and financially interdependent with the vacating tenant.

If the tenant or leaseholder of your apartment has re-

cently died or vacated the apartment and you believe that you have succession rights, you should seek advice on whether to notify the landlord that the tenant has vacated.

If a tenant vacates the apartment and continues to sign leases or submit rent payments in his or her name, it may damage a potential succession claim and disallow a family member from remaining in the apartment.

If the tenant of your apartment has vacated or passed away and you wish to be recognized as the new legal tenant, please seek legal advice as soon as possible. You can visit HCC for further information during intake hours. Our intake hours are Mondays from 4:00pm to 6:30pm and Thursdays from 10:00 AM to 12:30 PM. To be eligible for our services you must live between 34th and 72nd Street, from Eighth to Twelve Avenues and meet our income guidelines. if you're not eligible for intake, call us at 212-541-5996 and reserve a spot for our free legal clinic, which are open every Monday night from at 7:00 pm - 9:00 pm. ■
